Town Council Meeting
October 2, 2017**

Meeting Called to Order at 7:00 PM

Pledge of Allegiance

Roll Call:

Councilperson Clark, Mayor Redding, and Councilperson Stinnette, and Councilperson Burns were present. Councilperson Marlatt was absent. All accounted for.

Mayor Redding asked for a moment of silence in the wake of the massacre in Las Vegas, Nevada.
