Permission for Lance to purchase ~\$2,500.00 in hand tools from Harbor Freight. Money already in 2019/20120 budget. Motion made by Councilperson Schirmer and seconded by Councilperson Cronk. Motion passed.

Mayor Redding made a request to Council that the Community Center Board be dissolved, removing signers on the Community Center Board checking account held at Oregon Trail Bank in Cheyenne, and adding Clerk/Treasurer Clough and Mayor Redding to the checking account as signers. Motion was made by Councilperson Cronk and seconded by Councilperson Burns. Motion passed.

Midwest Assistant Group- Permission from Council to allow them to map the water/sewer lines in Chugwater at no cost to the city. Motion made by Councilperson Schirmer and seconded by Councilperson Cronk. Motion passed.
